Thank you for your inquiry about our school. I would like to invite you to visit us, look over the programs, and meet our staff. We offer four programs plus C.E.U. hours to continue meeting requirements for license renewal.

Programs offered: Cosmetology (1540 hours) Massage Therapy (720 hours) and Teachers Training (1000 Hours)

Cosmetology Program 1540 hours: 12 months

The student must have a GED or High School Diploma and be a U.S. Citizen or show proof of intent of becoming a citizen. The student is furnished with a kit filled with all the necessary tools, a mannequin, textbooks, and a black lab coat. Each student must provide their own black scrubs including white shoes.

Attendance: is 9:00 am – 5:00 pm Wednesday, Thursday, Friday and Saturday. Saturday is mandatory for all students.

Massage Therapy 720 hours: Approximately 7 ½ months .

The student must have a GED or High School Diploma and be a U.S. Citizen or show proof of intent to become a Citizen. The student is furnished with necessary equipment and supplies owned by the school.

Books and 1 set of scrubs are included in the tuition cost. Student must provide white shoes.

Financial Aid is available for those who qualify.

Attendance: Tuesday 5:00 pm to 9:00 pm, Wednesday 8:30 am to 5:00 pm Thursday 5:00 pm to 9:00 pm, Saturday 8:30 am to 5:00 pm, a total of 24 hours per week.

Teachers Training 1000 Hours: Approximately 6 months .

Attendance is the same as for Cosmetology students. However the student must hold a active Cosmetology License to register for the program.

We will be glad to help you fill out all necessary forms and assist you in any way we can. The Cosmetology and Teachers program has Pell Grants and Loans available; however the Nail Program is cash pay only. Massage Program has both Pell Grants and Loans. TO APPLY FOR FINANCIAL AID FOR ANY OF THE PROGRAMS, YOU MUST BRING IN A DIPLOMA OR GED AND INCOME TAX RETURN AND VAILD DRIVERS LICENSE.

We suggest all students apply to see if they qualify.
